Whereas it is deemed seepedient and desirable, for the safety of foot passengers and others, to regulate the speed of bieycles within the lity limits and to provide for the carrying of lanterns at night by persons riding bicycles upon the streets of the said bity;

Now Therefore the Mayor and bouncil of the bity of Thinnipeg in bouncil assembled mack as follows:-

I. No person shall ride a bicycle within the limits of the bity of Thinnipeg of upon any of the streets, squares or lanes thereof at a greater rate of speeds and eight miles per lour. Any person or persons guilty of an infraction of any of the prodisions of this Bylaw shall, upon conviction before the Mayor, or any fustices of the Seace Laving juriodiction in the City of Thinnipeg, on the oath or affirmation of any creditable ritness, forfeit and pay at the discretion of the said Mayor, Justice or Justices for each offence convicting, a proalty not socceeding the sum of fifty dollars and costs for each offence, and in default of payment thereof it shall be lawful for the Mayor, Police Magistrate, Justices or Justices of the Peace convicting as aforesaid to insue to issue a marrant under his hands and seal, or in case the said Justices of

Deace, or any two or more of them acking together therein, then under the hand and seal of one of them, to levy the said proally and costs or proally or costs only, by distress and sale of the offender's or offenders' goods and chattels, and in case of no sufficient distress to satisfy the said penalty and coots or proalty or costs, it shall and may be lawful for the Mayor, fustice or fustices convicting as aforesaid, or of any one of them, to commit the offender or offenders to the common jail or any lock-up house in the bity of Thinnipeg for any periods not receeding lumity- one days, unless the said penalty and costs or penalty or costs be sooned paid.

## **Bylaw No. 1198**

A By-law of the City of Winnipeg to regulate the speed of bicycles and provide for the carrying of lanterns at night.

Whereas it is deemed expedient and desirable, for the safety of foot passengers and others, to regulate the speeds of bicycles within the City limits and to provide for the carrying of lanterns at night by persons riding bicycles upon the streets of the said City;

Now Therefore the Mayor and Council of the City of Winnipeg in Council assembled enact as follows: -

- 1. No person shall ride a bicycle within the limits of the City of Winnipeg or upon any of the streets, squares or lanes thereof at a greater rate of speed than eight miles per hour.
- 2. That on and after the first day of January next All persons riding bicycles upon any of the streets, squares or lanes of the City of Winnipeg or within the limits of the City of Winnipeg between half an hour after sunset and daylight, shall carry lighted lanterns attached or fixed to the head or handle-bar of such bicycles so as to be easily seen and distinguished by foot passengers and other persons upon the said streets.
- 3. Any person or persons guilty of an infraction of any of the provisions of this Bylaw shall, upon conviction before the Mayor, or any Justice or Justices of the Peace having jurisdiction in the City of Winnipeg, on the oath or affirmation of any creditable witness, forfeit and pay at the discretion of the said Mayor, Justice or Justices for each offence convicting, a penalty not exceeding the sum of fifty dollars and costs for each offence, and in default of payment thereof it shall be lawful for the Mayor, Police Magistrate, Justice or Justices of the Peace convicting as aforesaid to issue a warrant under his

hand and seal, or in case the said Mayor, Justice or Justices of the Peace, or any two or more of them acting together therein, then under the hand and seal of one of them, to levy the said penalty and costs or penalty or costs only, by distress and sale of the offender's or offenders' goods and chattels, and in case of no sufficient distress to satisfy the said penalty and costs or penalty or costs, it shall and may be lawful for the Mayor, Justice or Justices convicting as aforesaid, or of any one of them, to commit the offender or offenders to the common jail or any lock-up house in the City of Winnipeg for any period not exceeding twenty-one days, unless the said penalty and costs or penalty or costs be sooner paid.
